RESOLUTION NO. 2020-22

A RESOLUTION OF THE BOROUGH OF MIFFLINBURG, UNION COUNTY, PENNSYLVANIA, AMENDING THE ESTABLISHED AND ADOPTED SCHEDULE OF FEES AND RATES UNDER THE MIFFLINBURG BOROUGH SEWER SYSTEM ORDINANCE.

WHEREAS, the Council of Mifflinburg Borough, Union County, Pennsylvania, pursuant to Part 2 of the Mifflinburg Borough Sewer System Ordinance, as amended, is authorized to establish a Schedule of Fees and Rates pertaining to the Sewer System.

NOW, THEREFORE, upon motion properly made, seconded, and carried, the Council of Mifflinburg Borough declares and resolves:

The Council of Mifflinburg Borough hereby establishes and adopts the following Schedule of Fees and Rates, such fees and rates to be paid to the Borough in accordance with the Mifflinburg Borough Sewer System Ordinance and this Resolution:

Section 13. Connection Fees:

The connection fees required in Section 12 hereof shall be paid to the Borough Treasurer in accordance with the following provisions:

- 13.1 Before connecting to the Borough's sewer system, the owner of the improved property shall pay the Borough connection fees, customer facilities fees, and tapping fees, which fees shall be established from time to time by resolution of the Borough Council. Sewer connections made in a development or subdivision wherein the subdivision has constructed or installed all sewer lines connections, extensions, additions and improvements to the sewer system within said development must be approved by the Borough Engineer or other Borough official authorized to grant such approval. (Ord. 2003-5)
- 13.2 The Borough of Mifflinburg shall require an official sewer connection permit for each connection. The Borough may levy an inspection fee for each such sewer permit, plus compensation may be assessed for the time, materials or equipment required to complete the inspection of each sewer connection. The fee for an official sewer connection permit and the amount of compensation assessed shall be established from time to time by resolution of the Borough Council. (Ord. 2003-5)

Section 14. Sewer Rentals:

- 14.1 Billing Schedule: All sewer rentals shall be billed on a monthly basis.
- 14.2 Schools within the Borough shall pay a rental fee of Two Dollars and thirty five cents (\$2.35) per month per student and employees, based upon a census the employees and students obtained in September of each year at the beginning of the new school term.
- 14.3 The sewer rate charges for all other users within the Borough of Mifflinburg shall be a base rate charge of \$46.50 per month, plus \$5.57 per 1,000 gallons of water consumed as registered by the meter used in computing the water bills by the Borough of Mifflinburg.
- 14.4 Consumption Charges to Municipalities Outside the Borough:
- Buffalo Township and Limestone Township shall pay a rate of \$14.89 per 1,000 gallons of water consumption. West Buffalo Township shall pay a rate of \$13.41 per 1,000 gallons of water consumption.
- 14.5 The sewer billings for customers of the Borough of Mifflinburg shall be mailed the first day of each month and shall be due and payable in full twenty (20) days thereafter. Any and all bills not paid in full within the first 20 days shall be assessed a penalty charge of five percent (5%) on the current month's outstanding balance. All bills over sixty (60) days past due shall be sufficient and just cause for the Borough to disconnect water utility services to prevent further use of the sewer utility and to impose a municipal lien on the property serviced by said sewer services.
- 14.6 All future sewer rates are hereby authorized to be amended by resolution of the Borough Council of the Borough of Mifflinburg.


All ordinances and resolutions or parts of ordinances and resolutions inconsistent herewith, be and the same are hereby repealed.




