ORDINANCE NO. 2022-01

AN ORDINANCE OF THE BOROUGH OF MIFFLINBURG, UNION COUNTY, PENNSYLVANIA, AMENDING CHAPTER 28 OF THE CODE OF ORDINANCES OF MIFFLINBURG BOROUGH (WATER) TO INCLUDE REFERENCE TO THE BOROUGH OF MIFFLINBURG'S CONSTRUCTION AND DESIGN STANDARDS FOR THE SUPPLY OF WATER.

WHEREAS, pursuant to 8 Pa.C.S. § 3301.1, the Borough of Mifflinburg, Union County, Pennsylvania (the "Borough"), is authorized to adopt ordinances and is further authorized to amend existing ordinances by the enactment of subsequent ordinances; and

WHEREAS, pursuant to 8 Pa.C.S. § 3301.1(c), the Borough is authorized to adopt resolutions for any purpose, including for setting forth certain rules, regulations, and standards pertaining to Borough ordinances; and

WHEREAS, the Borough has determined it to be in the best interest of the health, safety, and welfare of the residents of the Borough to enact certain construction and design standards for the Supply of Water pursuant to and in accordance with the Borough's Subdivision and Land Development Ordinance (Ch. 23 of the Mifflinburg Code of Ordinances); and

WHEREAS, the Borough desires to further clarify its existing regulations and provide, by resolution, for more specific construction and design standards for such Supply of Water; and

WHEREAS, the Borough desires to amend its Water Ordinance to make reference to the aforementioned Resolution; and

WHEREAS, the purpose of this Ordinance is to amend the existing Ordinance for Water to include a reference to the Borough's Construction and Design Standards for the Supply of Water;

NOW, THEREFORE BE IT ENACTED AND ORDAINED by the Council of the Borough of Mifflinburg, in a public session duly assembled, and it is enacted and ordained as follows:

A. INSERTION OF SECOND PART TO CH. 28 OF THE CODE OF ORDINANCES

Chapter 28 of the Code of Ordinances of Mifflinburg Borough (Water) shall be amended by adding Part 2. Construction and Design Standards for the Supply of Water, as follows:

Part 2. CONSTRUCTION AND DESIGN STANDARDS FOR THE SUPPLY OF WATER


§ 28-201. General Provisions.

All construction and design standards shall comply and be in accordance with the Borough's Construction and Design Standards for the Supply of Water, as from time to time reenacted and amended by resolution of Borough Council.




