RESOLUTION NO. 2023-15

A RESOLUTION OF THE BOROUGH OF MIFFLINBURG, UNION COUNTY, PENNSYLVANIA, AMENDING THE RATES UNDER THE MIFFLINBURG BOROUGH ELECTRIC SYSTEM ORDINANCE.

WHEREAS, the Council of Mifflinburg Borough, Union County, Pennsylvania, pursuant to Section 18.3 of the Mifflinburg Borough Electric System Ordinance, as amended, is authorized to amend the rates pertaining to the Electric System.

NOW, THEREFORE, upon motion properly made, seconded, and carried, the Council of Mifflinburg Borough declares and resolves:

The Council of the Borough of Mifflinburg hereby amends and adopts the following Schedule of Electric Service Rates to be paid to the Borough in accordance with the Borough of Mifflinburg Electric System Ordinance and this Resolution:

Section 20. Residential Service Rate (Rate R):

4. Rate Table. The customer's monthly bill shall be the sum of the customer charge and energy charge:

- 4.1 Customer Charge: \$7.32
- 4.2 First 500 KWH: \$0.1400 per KWH
- 4.3 All Additional KWH: \$0.1238 per KWH

Section 22. General Light and Power Secondary Service (Rate GLP-1) (1 KW Minimum):

4. Rate Table. The customer's monthly bill shall be the sum of the customer charge, capacity and energy charges:

- 4.1 Customer Charge: \$7.32
(including first 3 kilowatts of the billing demand)
- 4.2 Capacity Charge: \$8.11 per kilowatt for all kilowatts of
the Billing KW over 3 KW
- 4.3 Energy Charge: \$0.1268 per KWH.

Section 23. General Light and Power Secondary Service (Rate GLP-3) (25 KW Minimum):

4. Rate Table. The customer's monthly bill shall be the sum of the customer charge, capacity and energy charges:

- 4.1 Customer Charge: \$7.32
- 4.2 Capacity Charge: \$7.34 per kilowatt for all kilowatts
of the Billing KW
- 4.3 Energy Charge:
 - 4.3.1 First 150 KWH per kilowatt of the billing KW - \$0.1149 per KWH
 - 4.3.2 Next 100 KWH per kilowatt of the billing KW - \$0.0921 per KWH
 - 4.3.3 All additional KWH - \$0.0883 per KWH

Section 25. General Light and Power Primary Service (Rate GLP-4) (25 KW Minimum):

4. Rate Table. The customer's monthly bill shall be the sum of the customer charge, capacity and energy charges:

- 4.1 Customer Charge: \$7.32
- 4.2 Capacity Charge: \$7.34 per kilowatt for all kilowatts
of the Billing KW
- 4.3 Energy Charge:
 - 4.3.1 First 150 KWH per kilowatt of the billing KW - \$0.1108 per KWH
 - 4.3.2 Next 100 KWH per kilowatt of the billing KW - \$0.0891 per KWH
 - 4.3.3 All additional KWH - \$0.0815 per KWH


All ordinances and resolutions or parts of ordinances and resolutions inconsistent herewith, be and the same are hereby repealed.


This Resolution shall become effective immediately.




