The Borough of Mifflinburg cannot prevent you and/or your children from becoming exposed to, contracting, or spreading COVID while utilizing the Mifflinburg Borough Pool. Although vaccinations are available, it is unknown whether such vaccinations prevent against the presence of the disease entirely. Therefore, if you choose to utilize the Mifflinburg Borough Pool, you may be exposing yourself to and/or increasing your risk of contracting or spreading COVID.

In order to utilize the Mifflinburg Borough Pool, you hereby choose to accept the risk of contracting COVID by you and/or your children. You further acknowledge that the use of the Mifflinburg Borough Pool is of such value to you and/or your children, that you accept the risk of being exposed to, contracting, and/or spreading COVID in order to use the Mifflinburg Borough Pool.

BY ENTERING THE MIFFLINBURG BOROUGH POOL, YOU ACKNOWLEDGE THAT YOU HAVE READ AND FULLY UNDERSTAND THE ABOVE WARNING CONCERNING COVID.

WAIVER OF LAWSUIT/LIABILITY

You understand that visiting and/or participating in activities at the Mifflinburg Borough Pool involves risk of injury. You understand these risks are entirely your responsibility. You expressly assume these risks. In particular, you are aware of the risks and hazards inherent upon entering the pool area and you choose to voluntarily enter the premises, knowing the conditions might become more hazardous and/or dangerous for yourself and/or your children and you voluntarily assume all such risks, loss, damages, or injury that may be sustained by your entering and/or participation in pool-related activities.

By signing this release of liability and visiting and/or participating in activities at the Mifflinburg Borough Pool, and in consideration for being permitted to participate in pool-related programs, you do hereby, for yourself, your heirs, executors, administrators and assigns, and/or for any additional family members and minors in your care, fully and forever release, indemnify, and discharge the Borough of Mifflinburg and its officers, officials, departments, and other representatives and their heirs, administrators, successors and assigns, from any and all manner of action, cause of action, suits, debts, accounts, controversies, damages, claims and demands whatsoever, which you or your legal representative, and/or any minors in your care may have or acquire against the Borough of Mifflinburg and its officers, agents and other representatives, by reason of any loss resulting from personal injury or damage to personal property belonging to you and/or any minors in your care which may occur during or by reason of your, and/or any additional family members' or minors' in your care visiting and/or participating in activities at the pool, whether the same be known or unknown, anticipated or unanticipated. You fully and forever release and discharge the Borough of Mifflinburg and its volunteers and vendors, employees and agents from any and all negligent acts and omissions in the same. You hereby grant the Borough of Mifflinburg and any of its officials, officers, agents and other representatives full authority to take whatever action they may consider to be warranted regarding your, and/or any additional family members' or minors' in your care, health and safety, and you fully release the Borough of Mifflinburg, its officials, officers, agents and other representatives from any liability for such actions taken on your behalf or on behalf of any additional family members or minors in your care.

You understand that no health and/or accident insurance is provided by the Borough of Mifflinburg. You also understand and agree, for yourself, and/or for any minors in your care, that you are solely responsible for the cost and expense for furnishing medical or other insurance to cover any expenses related to any such personal injuries or property damage.

Please review the pool rules on the previous page and keep rules page for your reference. I have read and understand the Mifflinburg Community Pool and Park Rules. I agree to abide by them and will review them with my children. Furthermore, I agree to indemnify and hold harmless the Borough of Mifflinburg, its officials, employees, agents, and staff, including but not limited to the Parks and Recreation Department, its personnel and instructors, from any and all liability in connection with the exposure, infection, and/or spread of COVID.

I understand that the fee for a season pass is non-refundable under any circumstances and may not guarantee entrance to the pool if same is closed due, but not limited to, inclement weather, lack of adequate pool staff and lifeguards necessary to safely open and operate the pool, water quality levels, pool maintenance, acts of god, public health emergencies including COVID-related exposure and/or outbreak or if there is a change in the rules and regulations promulgated by the PA Department of Health or any further directives and/or orders issued by the Governor. I understand that the Borough of Mifflinburg retains the right to, in its discretion, close the pool at any time.

MIFFLINBURG COMMUNITY POOL RULES

1. Season Ticket Holders MUST present Ticket at Front Desk.
2. No Children under Eight (8) Years of Age without a Responsible Individual or Adult.
3. No Alcoholic Beverages or Drugs.
4. No Smoking or Tobacco Use Including E-cigarettes.
5. No Chewing Gum.
6. No Profanity.
7. No Weapons.
8. Do Not Distract Lifeguards on Duty.
9. No Horseplay (pushing, shoving, dunking, etc.).
10. No Running.
11. Flips Permitted on Diving Boards Only.
12. No Diving in Less than Five (5) Feet of Water.
13. Only One (1) Person at a Time on any Ladders.
14. Only One (1) Person at a Time on Diving and Sliding Boards.
15. Feet First Only on All Sliding Boards.
16. No Swimming Near or Under Diving and Sliding Boards.
17. No Goggles, Fins, Masks, Snorkels or Personal Flotation Devices.
18. Bathing Suits Required. Hemmed "Cut-Offs" Acceptable.
19. Keep Bathroom, Pool and Park Areas Clean.
20. Bicycles Must Be Kept in Stands.
21. Only Pool Personnel Permitted in Concession and Office Area.
22. Check all Valuables at Front Desk (Pool Not Responsible for Lost/Stolen Items).

Mifflinburg Community Park Rules

1. No Alcoholic Beverages or Drugs.
2. No Smoking or Tobacco Use Including E-cigarettes.
3. No Pets.
4. No Bicycles or Board Use in the Pavilions.
5. No Profanity.
6. No Littering.
7. No Sitting or Standing on Picnic Table Tops.
8. No Drawing or Carving on Picnic Tables or Pavilion.
9. No Intimidation of Other Park Visitors.
10. No Loitering.
11. No Weapons.
12. The Borough is Not Responsible for Lost/Stolen Items.

The Mifflinburg Police Department and the Park Directors have the authority to temporarily remove any person or persons from the park or recreation area for up to five (5) days for violation of any of the above rules and regulations. Permanent removal (longer than five (5) days) shall be made at the discretion of the Mayor of Mifflinburg.
