RESOLUTION NO. 2025-21

A regular meeting of Mifflinburg Borough Council was convened at 6:00 PM on Tuesday, 16 September, 2025, in the Mifflinburg Municipal Building, 120 North 3<sup>rd</sup> Street, Mifflinburg, Pennsylvania. At this meeting a quorum of Mifflinburg Borough Council was present and did adopt the following resolution.

WHEREAS, Mifflinburg Borough Council is empowered to establish regulations pertaining to the operation of the municipal electrical system, and;

WHEREAS, Mifflinburg Borough Council has determined that a revised fee schedule for electric security deposits is necessary to offset potential losses due to failure to comply with tariff provisions by customers of the municipal electric system, now therefore be it;

RESOLVED, that the following rules, regulations and fee schedules be utilized for determining the amounts of electric security deposits to be charged customers of the municipal electric system, and;

RESOLVED, that these following rules, regulations and fee schedules shall remain in effect until such time as Mifflinburg Borough Council shall chose to amend, or revoke, said rules, regulations and fee schedules by means of enactment of a subsequent resolution.

Electric security deposits shall be based upon the average monthly consumption of the metered location for the previous twelve (12) month period, provided that any month(s) in which the metered location was unoccupied shall be eliminated in computing the average monthly consumption. With respect to nonlienable properties located in lots not owned by the electric customer, a security deposit of \$200.00 will be required.

Electric security deposits shall be collected by the Borough of Mifflinburg in accordance with the following deposit schedule prior to the electric service being placed into an account name other than that of the current owner of the property being provided with electrical service.



0 - 1000	\$	125.00
1001 - 3000	\$	350.00
3001 - 7500	\$	900.00
OVER 7500	\$	1,400.00

Electric security deposits will be refunded upon the earlier of two events:

1. An account is closed and all bills due and payable for electric consumption at the metered location have been satisfied with the Borough of Mifflinburg, or;
2. An account has been kept current, with no delinquent payments, for a period of sixty (60) consecutive months.
