BOIL YOUR WATER BEFORE USING

You or someone using the drinking water in Mifflinburg Borough on the Hill in the Old Orchard Lane area **May Be At Increased Risk From Microbial Contamination.**

We routinely monitor the conditions in the distribution system. On August 24, 2026, we experienced a loss of positive water pressure due to water being shut-off to make a new watermain connection. A loss of positive water pressure is a signal of the existence of conditions that could allow contamination to enter the distribution system through back-flow by back-pressure or back-siphonage. As a result, there is an increased chance that the water may contain disease-causing organisms.

What should I do?

DO NOT DRINK THE WATER WITHOUT BOILING IT FIRST. Bring all water to a rolling boil, let it boil for one minute, and let it cool before using; or use bottled water. You should use boiled or bottled water for drinking, making ice, washing dishes, brushing teeth, and food preparation until further notice.

Inadequately treated water may contain disease-causing organisms. These organisms include bacteria, viruses, and parasites, which can cause symptoms such as nausea, cramps, diarrhea, and associated headaches.

These symptoms, however, are not caused only by organisms in drinking water, but also by other factors. If you experience any of these symptoms and they persist, you may want to seek medical advice.

Guardians of infants and young children and people at increased risk, such as pregnant women, some of the elderly, and people with severely compromised immune systems, should seek advice from their health care advisors about drinking this water. What happened? What is being done?

Due to new watermain construction, we will be shutting off water starting at 7AM on 8/24/2026 to all of Buggy Lane, Crestview, Mountainview, Lime Ridge, Borough Line Roads, Hilltop Lane and Old Orchard Lane as well as Limestone Twp Customers to make the tie in of the new main. Therefore, this will require a boil water advisory (BWA) starting on 8/24/2026 until further notice. Effected customers should boil their water before consumption or use bottled water. You will be notified when the boil water advisory is lifted. We will be required to take two water samples on consecutive days in order to lift the advisory.

We will inform you when all corrective actions have been completed and when you no longer need to boil your water.
